

ADVERTISEMENT FOR BIDS

Sealed bids for the Construction of a new Administrative and Security Facility for the Gulfport Small Craft Harbor will be received by the City of Gulfport at the Procurement Department, 1410 24th Avenue, Gulfport, MS 39501, until Ten O'clock A.M. Local Time on December 10, 2010 and then publicly opened and read aloud.

Instruction to Bidders, Form of Contract, Form of Contract Bond, Drawings, Specifications and other Contract Documents may be examined at the following locations:

Copies may be obtained in Adobe PDF® format for a non-refundable fee of \$50.00 per disk. Fee will be waived for ABC/AGC members. Hard copies of Drawings and Project Manual are available upon request for a non-refundable fee of \$200.00.

Bids shall be accompanied by a Bid Bond or Certified Check for five percent (5%) of the base bid. The successful bidder shall be required to furnish a Performance Bond for 100% of all labor and materials in the project.

Single stipulated sum bids will be received for all work required by the Contract Documents in accordance with the Instructions to Bidders. The project will be awarded to the lowest and best bidder. However, the owner reserves the right to accept or reject any or all bids or to waive any informality.

The successful bidder must adhere to the Owner's policy concerning non-discrimination without regard to race, creed, color, age, sex, national origin or handicap. A Certificate of Responsibility classification issued by Mississippi State Board of Public Contractors is required. Bidders shall agree to hold bids open for a period of up to sixty (60) days.

The owner is NOT responsible for bids which are mailed to the wrong address or which arrive in the mail after the designated bid opening time. Bids may be delivered in person to the Owner's office prior to the bid opening at the time, date and location listed above. The City of Gulfport assumes no responsibility for premature opening by any City of Gulfport employee

The outside of the bid envelope shall be plainly marked "Harbor Services Facility". The bidder must list all applicable State and local license and certificate numbers on the outside of the bid envelope. For bids exceeding \$50,000.00, Bidder must indicate his Certificate of Responsibility Number on the outside of sealed proposal as required by Mississippi Law. Effective July 1, 2010; Per MS Code 31-3-21(3); any bid submitted by a nonresident contractor which does not include the nonresident contractor's current state law pertaining to such state's treatment of nonresident contractors, shall be rejected and not considered for award. If no such law exists in the non-resident contractor's state, then the non-resident contractor may provide a statement to that effect
