

Comments (Including type of equipment and location, per C2(e), if applicable)  
The City of Gulfport requires 1 foot of freeboard. The surveyor recommends 1 foot of additional freeboard to allow for adjustments by the National Geodetic Survey to the City of Gulfport benchmarks which were established in 1997. Therefore, the surveyor recommends the finished floor elevation to be 20.00 feet. The project benchmark is a 60d nail set in a power pole near the southeast property corner at Elevation = 17.00 feet. The lowest elevation of equipment servicing in C2 e) is the AC unit located on the east side of the home.  
Note: This certificate is not a construction document and all elevations regarding the proposed residence should be discussed with the City of Gulfport Code Department.



Photo One Caption Front view






