The City of Gulfport requires an additional 12" freeboard; therefore, the minimum base flood elevation = 16' + 12" = 17'. Elevation of lower concrete slab = 10.0'. Elevation of existing house finished floor = 10.0'. There exist an elevator shaft inside the addition (4.55' x 5.60'); bottom of the elevator shaft is 9.6'. Elevation listed in C2e is an a/c unit on a metal platform located on the left side of the addition. Benchmark is a mag nail set in Bluff Lane in front of the property. Elevation of mag nail = 7.91'


