The City of Gulfport requires an additional freeboard 12" above the BFE; therefore, the minimum base flood elevation is 19'+12" = 20'. The Property Described listed on this certificate is for information purposes only. It is not intended to insure that the building is located on a particular legal parcel. The specific reference is according to municipal address only. Area listed in A8a is an elevator enclosure. A8c was determined by two smart vents with 200 sq in of flood openings each. Elevation listed in C2e is an air-conditioning unit on a platform. Benchmark is the northwest corner of the signal box slab located at the intersection of East Beach Boulevard and Hewes Avenue. Elevation of benchmark = 13.06'





Photo One Caption Rear & Right Side View 04/25/2018.


