

The City of Gulfport requires an additional freeboard 12" above the BFE; therefore, the minimum base flood elevation is 19'+12" = 20'. The Property Described listed on this certificate is for information purposes only. It is not intended to insure that the building is located on a particular legal parcel. The specific reference is according to municipal address only. A9b are smart vents rated for 200 sq. in. of flood openings. Elevation listed in C2e is an a/c unit on a platform located on the east side of the building. Pool pump located on the east side of the building elevation = 17.9'. 

Photo One Caption Front View 8/3/2019




