Executive Summary:

The Gulfport Police Communications center fielded **129,362** calls for service during 2014. This represents a **2%** decrease in calls for service when compared to 2013 in which **132,363** calls for service to the public were recorded. An increase of **14%** in documented police reports was also noted in 2014 with **29,421** when compared to 2013 with **25,084**.

Violent Crimes, *defined by the Federal Bureau of Investigation's as Murder, Forcible Rape, Robbery, and Aggravated Assault*, as a whole have decreased **1%** through 2014 when compared to 2013 but increased **9%** compared to the previous five year average. More specifically, Homicides increased **133%** with seven (7) being reported in 2014 where three (3) were reported during 2013. Homicides remained the same when compared to the previous five year average. Aggravated assaults decreased **20%** compared to 2013 but increased **20%** compared to the previous five-year average. Robberies are up **11%** in 2014 compared to the same time period of 2013 and have also increased **7%** compared to the previous five-year average. Reported Forcible Rapes have remained the same when compared to 2013 but decreased **4%** when compared to the previous five year average.

Property crimes increased **1%** compared to 2013 but has decreased **1%** when compared to the previous five-year average. Larcenies increased **4%** and Auto thefts increased **13%** when compared to 2013. However Burglaries are showing a **9%** decrease during the same period. On comparison with the previous five-year average Larcenies increased **9%** but Burglaries decreased **32%** and Auto thefts decreased **2%**.

Introduction

Data Source

On a national level, statistical information about crime is collected and reported in two ways. The first way is through the **Uniform Crime Reporting Program**. The UCR program is a nationwide, cooperative statistical effort of more than 17,000 city, university and college, county, state, tribal, and federal law enforcement agencies voluntarily reporting data on crimes brought to their attention. Since 1930, the FBI has administered the UCR program and continued to assess and monitor the nature and type of crime in the nation. The program's primary objective is to generate reliable information for use in law enforcement administration, operation, and management; however, its data has over the years become one of the country's leading social indicators. Criminologists, sociologists, legislators, municipal planners, the media, and other students of criminal justice use the data for varied research and planning purposes.

*In 2010 the Gulfport Police Department became the first law enforcement agency in the state of Mississippi certified by the FBI to report crime statistics using the **National Incident Based Reporting System or NIBRS**. This allows for a more timely reporting method that is software driven and reported directly to the FBI. Based on this the Gulfport Police Department will be using NIBRS for all future crime reporting. The crime numbers represented in this report were verified by the FBI on **01/22/2015**. These are crimes reported in 2014 and, as investigations develop new information, are subject to change. *More information on NIBRS reporting can be found on the Gulfport Police Department website at www.gulfportpolice.net**

While we recognize that many crimes go unreported to law enforcement authorities, on a local level, we do not have the resources to collect that data. As a result, the information in this report is based solely on crimes that were reported to the NIBRS program.

Reports released by the Gulfport Police Department previously have been scored using the UCR program which is limited reporting information compared to NIBRS. For this report we will compare the two major crime categories of Violent Crimes and Property Crimes to previous periods. Murder, Forcible Rape, Robbery, and Aggravated assault will be considered as Violent crimes. The category of Property crimes will contain Burglary, Larceny, and Auto theft.


In this report the reader will find the use of Group A Crimes. These have been defined by the FBI as: *Arson, Assault offenses, Bribery, Burglary/breaking and entering, Counterfeiting/forgery, Destruction/damage/vandalism of property, Drug/narcotic offenses, Embezzlement, Extortion/blackmail, Fraud offenses, Gambling offenses, Homicide offenses, Kidnapping/abduction, Larceny/theft offenses, Motor vehicle theft, Pornography/obscene material, Prostitution offenses, Robbery, Sex offenses (forcible and non forcible), Stolen property offenses, and Weapon law violations.*



Group A Crimes:

For the calendar year of 2014, Group A crimes increased **2%** from 2013 but decreased **2%** when compared to the previous 5 year average.

Factors Affecting Crime

It is generally assumed the reader of this report understands that many factors affect crime in a community. Some factors which are known to affect the volume and type of crime are:

1. Population density
2. Variations in composition of the population
3. Stability of population with respect to resident's mobility, commuting patterns, and transient factors.
4. Economic conditions, including median income, poverty level, and job availability.
5. Cultural factors and educational, recreational, and religious characteristics.
6. Family conditions with respect to divorce and family cohesiveness.
7. Effective strength of law enforcement agencies.
8. Policies of other components of the criminal justice system.
9. Citizens' attitudes toward crime
10. Crime reporting practices of the citizenry.


With regard to the effective strength of law enforcement, the reader should consider that an agency that significantly increases its enforcement efforts might see an increase in reported crime instead of a decrease.

As a result of the numerous factors that affect reported crime, this report will be limited to presenting only the numbers of specific crimes reported. We will not try to draw a correlation between the volume of crimes reported and any other social factor. Furthermore, the reader should use great caution against comparing crime trends presented in this report and those of other jurisdictions. Finally, the differences in methodology for gathering data make it unwise to compare the Uniform Crime Report to the National Crime Victimization Survey.

Intended Use

The purpose of this report is to present the reader with a larger picture of crime as it is reported within the city limits of Gulfport, MS. ***We will look specifically at public safety issues during calendar year 2014 and compare them to past periods.***

Violent Crimes:



Definitions

Violent crime is comprised of four offenses:

- 1.) Murder and non-negligent homicide
- 2.) Forcible rape
- 3.) Robbery
- 4.) Aggravated assault




Violent Crimes: (Homicide, Forcible Rape, Robbery, and Aggravated Assault)

During 2014 violent crimes, as defined in this report, comprised only **2%** of all reported Group A crimes. When viewed together, violent crimes were down **1%** compared to 2013 but were up **9%** compared to the previous five-year average.


The 24 month chart below shows an upward trend during the past 24 months in Violent Crimes overall in the City of Gulfport.



Homicide:

Homicides during 2014 increased **133%** with seven (7) reported compared to 2013 with three (3) being reported. They remained the same when compared to the previous five-year average. There was one (1) report of Justifiable Homicide reported in 2014 but is not counted as Murder or Non-negligent Homicide.



Rapes reported in 2014 remained the same when compared to 2013 but decreased 4% compared to the five-year average.



During this reporting period of 2014 Robbery increased **11%** when compared to 2013 and increased **7%** when compared to the previous five year average.





Aggravated Assaults:

Assaults in this section are comprised of three types:


- 1.) Aggravated assault (*cumulative totals found in Violent Crimes*)







Simple Assaults:

Property Crimes:



Definition

Property crime includes the offenses of:

1. Burglary
2. Larceny-theft
3. Motor vehicle theft

The object of the theft-type offenses is the taking of money or property, but there is no force or threat of force against the victims. Although arson is a crime that involves the destruction of property, we will not include it in this section.



Total Property Crimes:

Property crimes as a whole increased **1%** by the end of 2014 when compared to 2013. A decrease of **1%** was noted when compared to the previous five year average.


The trend line shows an upward trend of property crimes on the 24 month comparison.

During 2014 Burglaries decreased **9%** compared to 2013 and have also decreased **32%** when compared to the previous five year average.








Auto Theft:




Gulfport Police Communications Center:

Definition


911 phone calls- Any phone call coming into the Center on one of four designated E911 phone lines

Admin calls are showing a slight decrease






Calls for Service






Officer Initiated Calls for Service:






Citizen Initiated Calls for Service:

Calls for Service at the request of the general did not change when compared to 2013. A decrease of 2% was noted when compared to the five year average.



Total crashes for 2013 increased 1% when compared to 2012 and increased 1% compared to the previous five-year average.



Crashes involving property damage only increased **2%** compared to 2013 and increased **2%** compared to the previous five-year average.








Fatality Crashes:




DUI Arrests:

Arrests for driving under the influence decreased **16%** in 2014 compared to 2013 and were down **34%** compared to the previous five-year average.

DUI data was used from the court system in the past. This has transitioned to data being used from RMS. This data contains DUI arrests for 2009 and retroactive to 2007 which was the first full year data was available from GPD RMS. This data is obtained from the GPD Traffic Unit.





Alcohol related crashes:

Alcohol related crashes decreased **32%** when compared to 2013. A decrease of **28%** was noted when compared to the previous five year average. Alcohol related crashes made up **3%** of all crashes in the City of Gulfport for 2013.
