Comments This elevation certificate is for a new electrical vault. The number shown in item A8.c. represents the area certified for flood protection as shown in the specifications for Smart Vent Model 1540-520 called for in the plans provided to Knesal Engineering Service Inc. by Roy Anderson. According to the DFIRM Map dated November 15, 2007, adopted by the City of Gulfport and effective on February 29, 2008, this structure is located in Zone AE with a Base Flood Elevation of 15 feet. The City has a freeboard requirement of 1 foot; therefore the minimum floor elevation is hereby established as 16 feet. The lowest electrical equipment or machinery serving the building is a distribution panel inside the vault.

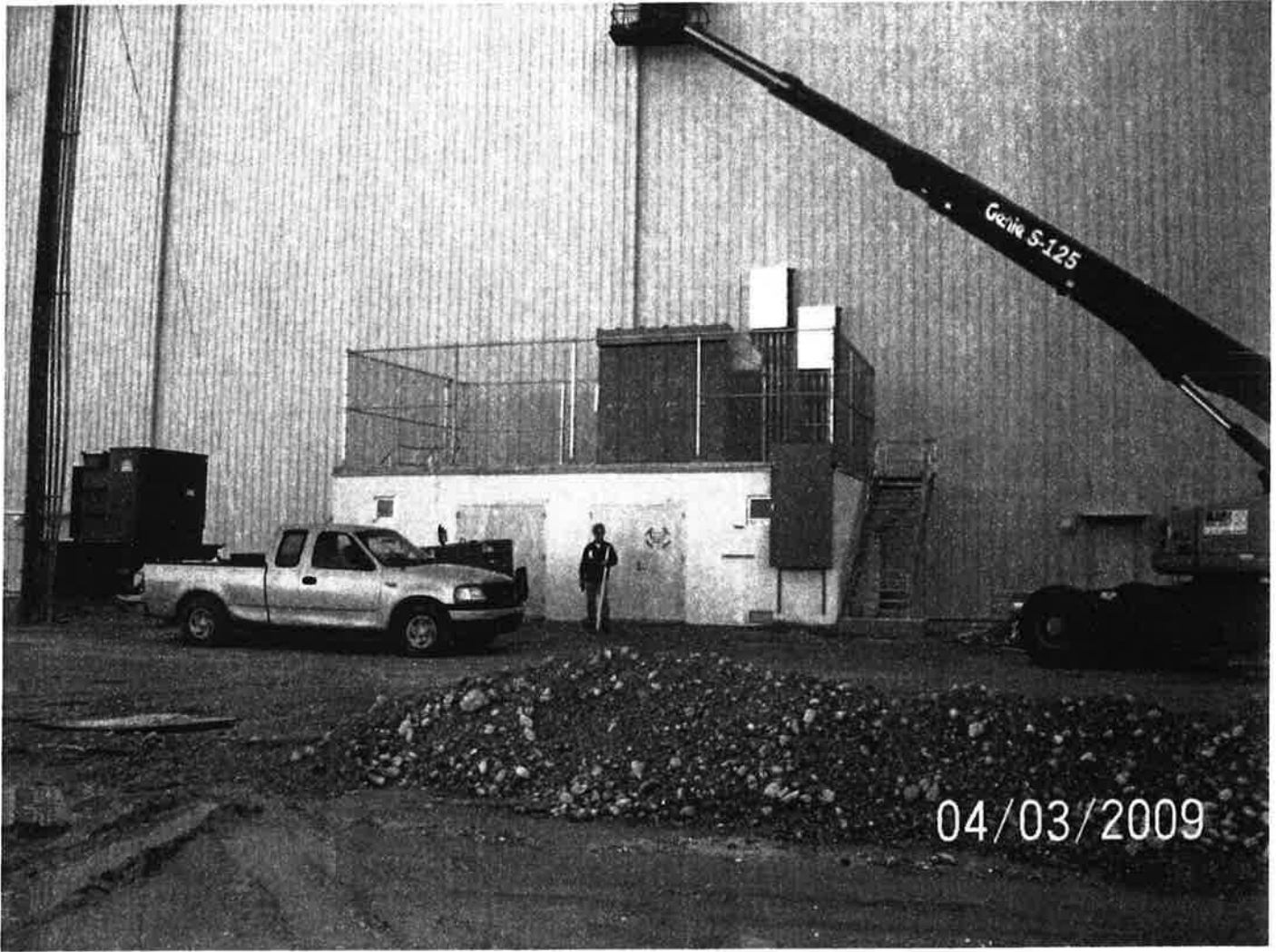
