and the same is hereby, voided and set aside, and that the defendant, CITY OF GULFPORT, is required to surrender the deed to
the Chancery Clerk for the First Judicial District of Harrison
County, Mississippi, for cancellation, and that the deed be,
and is hereby, adjudged cancelled of record. It it further,

ORDERED, ADJUDGED AND DECREED that the counterclaim of MYRICK DEVELOPMENTS, INC. be, and the same is hereby, dismissed with prejudice. It is further,
