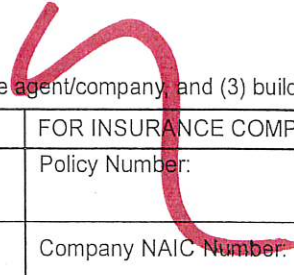

The City of Gulfport requires 1 foot of freeboard above the Base Flood Elevation in B9. The entire property is located within a Floodway. A benchmark (60d nail) was set in a power pole in front of the lot at elevation 6.00 feet.

The lowest elevation of equipment servicing in C2 e) is the AC unit located on a platform on the south side of the residence.
