

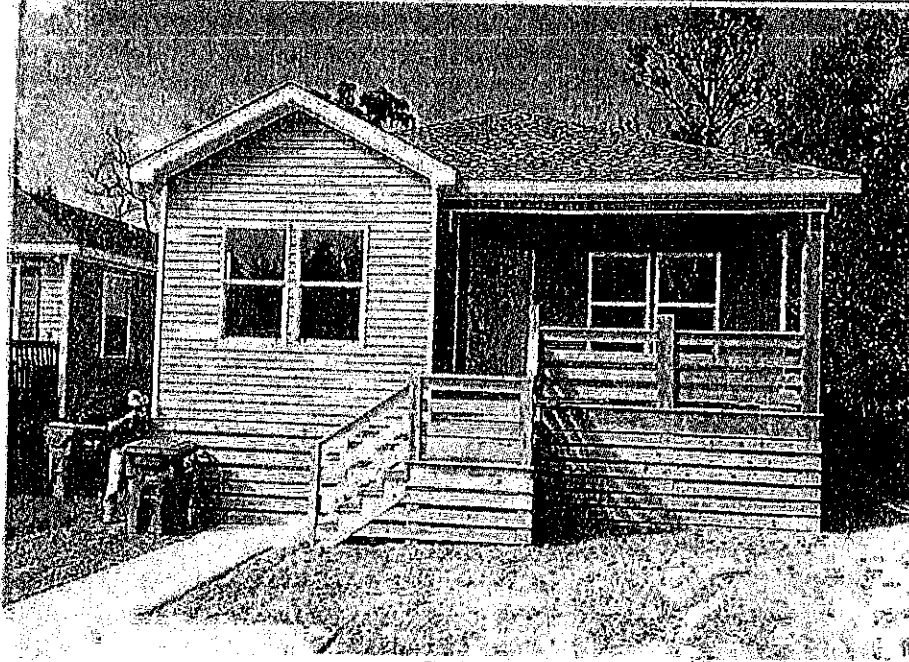

Photo One Caption FRONT VIEW 11/03/2016

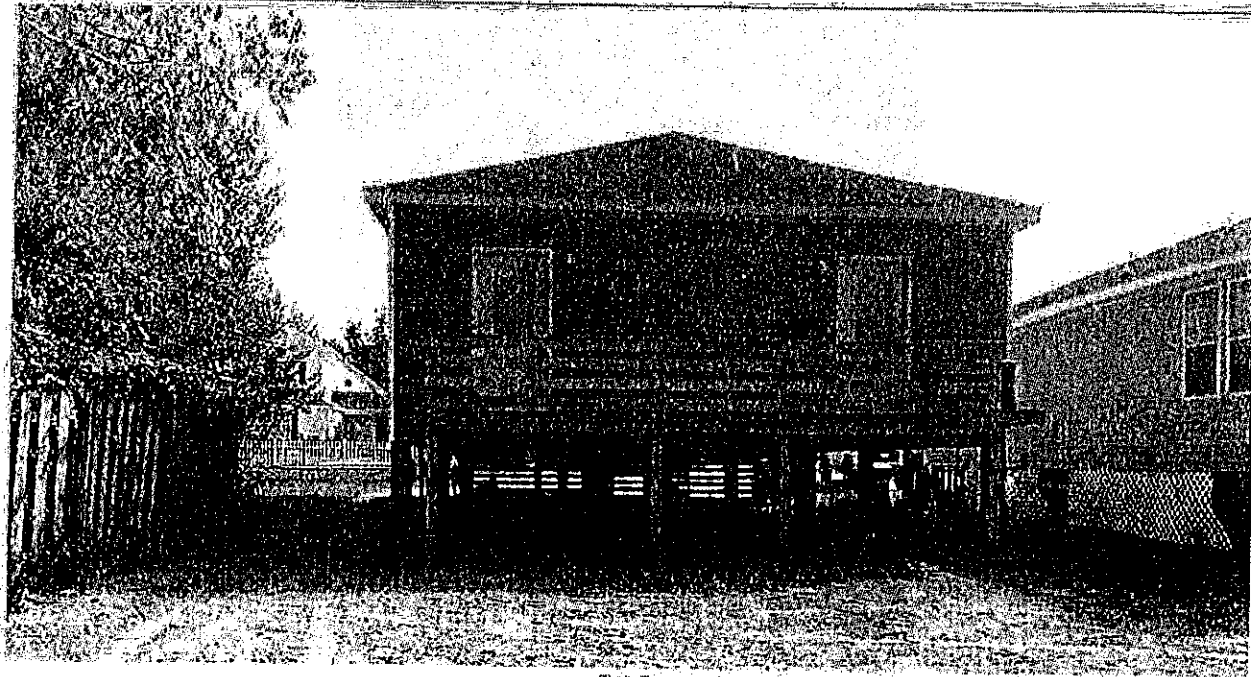

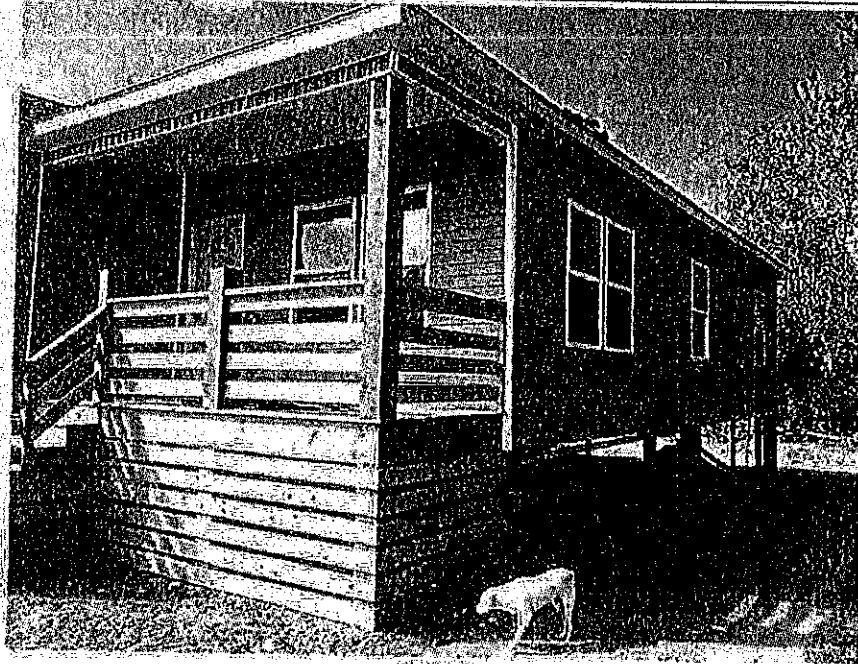
