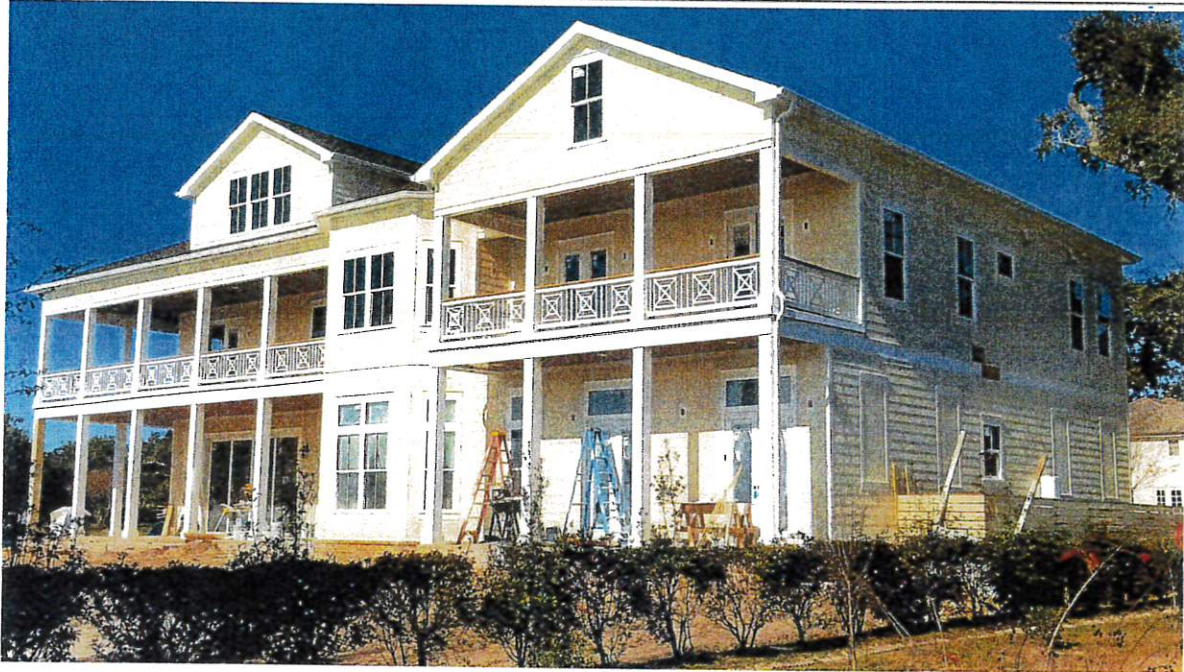

Photo One Caption FRONT VIEW

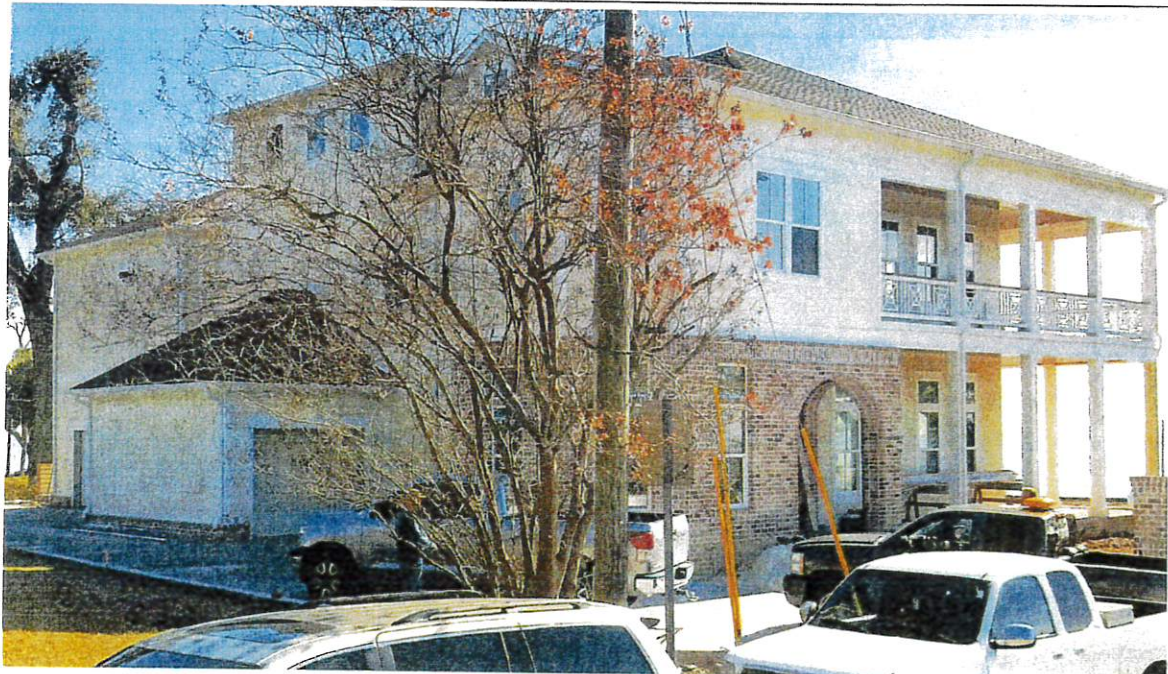

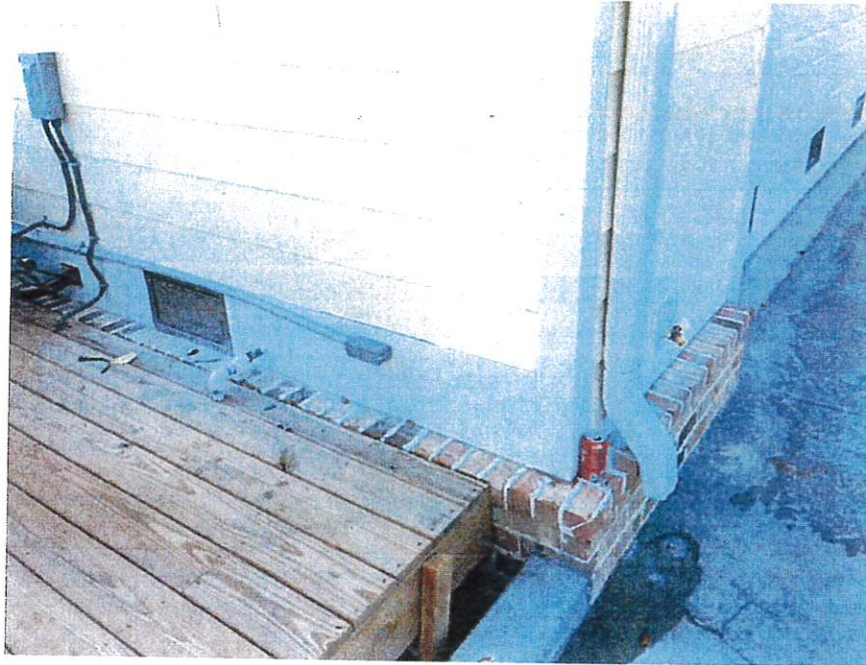

Photo One Caption GARAGE(S) & A/C NORTH VIEW

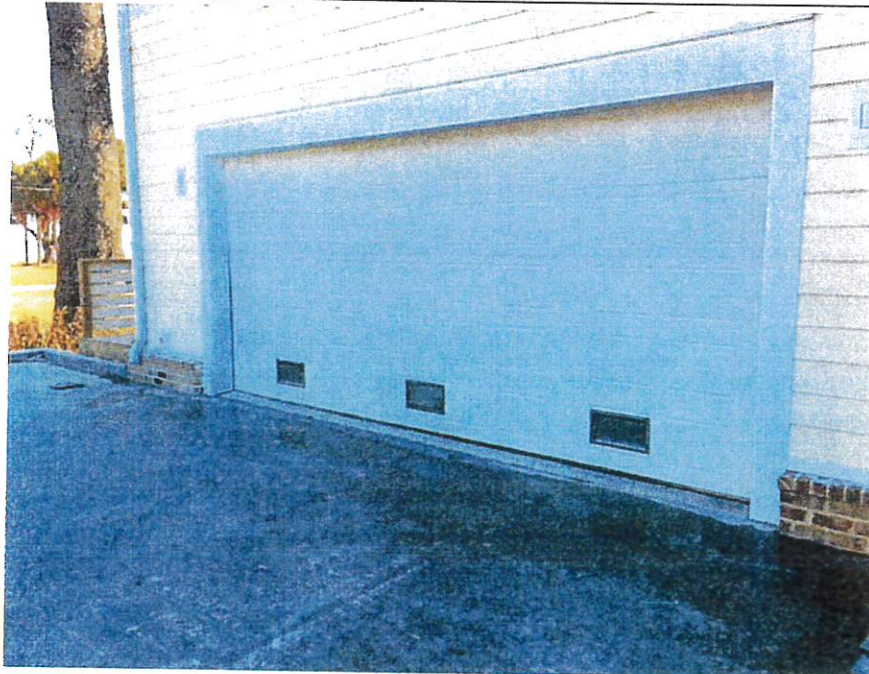
