

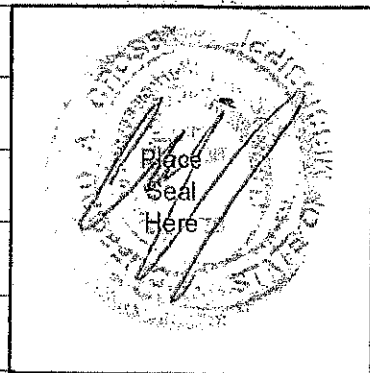

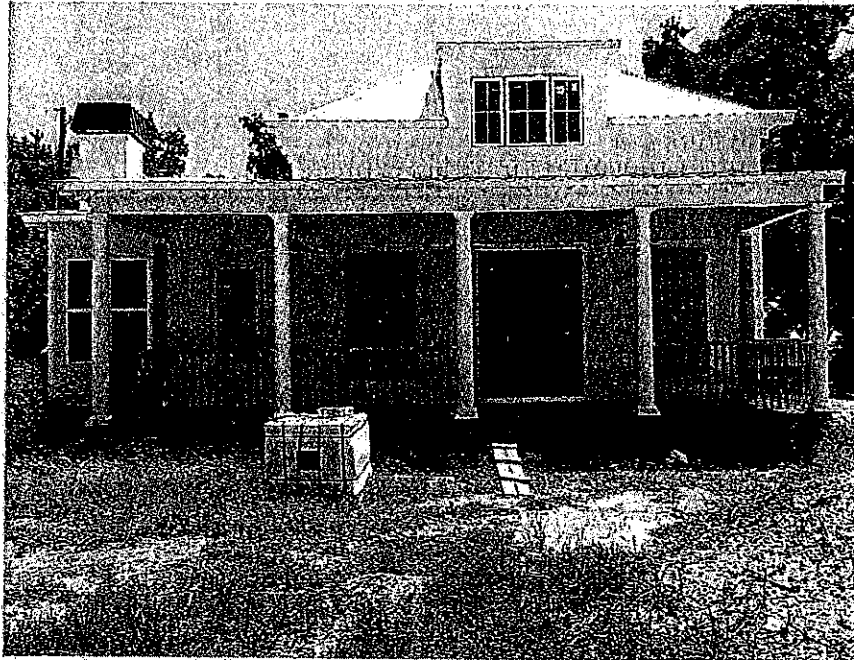

Photo One Caption FRONT VIEW 08/08/2018

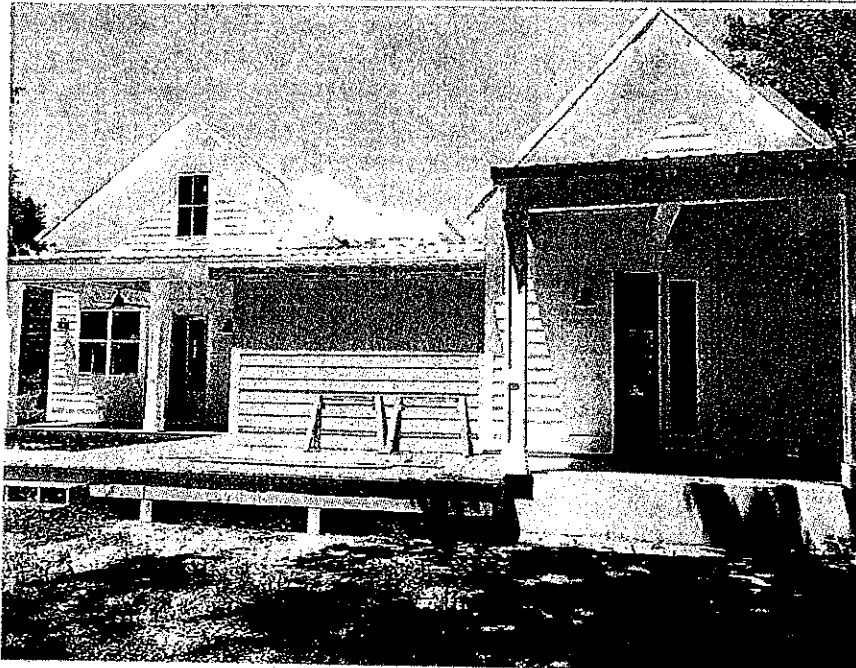
