 2.) The residence falls within Flood Zone "AE," with a Base Flood Elevation of 15,' as per attached FEMA flood map exhibit and survey plat.
 3.) Vertical ties were made at time of this certificate to City of Gulfport Benchmark "S-207-07," to report elevations listed hereon. Area is known to be within a area of subsidence based on recent NGS published reports. Additional vertical ties were made to NGS Benchmark disk B-368, and elevations shown hereon should be subtracted by 0.4'+/- to correspond to current sea level datum determined at time of this certificate.
 4.) Elevation reported on C.2(e) is top of A/C wood deck at SW corner of residence installed at time of this certificate.
