CITY OF GULFPORT NOTICE OF PUBLIC HEARINGS, DRAFT AVAILABILITY & COMMENT PERIOD 2023 CDBG & HOME ACTION PLAN

The U.S. Department of Housing and Urban Development (HUD) has announced that the City of Gulfport will receive a 2023 CDBG Entitlement allocation of \$723,144 and HOME Entitlement allocation of \$549,635. It does not anticipate generating program income during Program Year 2023. HUD has approved a deadline extension for the City of Gulfport to revise and resubmit its Program Year 2023 Action Plan, a component of its 2022-2026 Consolidated Plan.

As required by HUD, the City of Gulfport will conduct two public hearings to give residents opportunity to 1) present oral or written input about housing, community development and supportive housing needs; and 2) participate in development and implementation of the Action Plan.

To comply with HUD's resubmission deadline, the hearings are scheduled as follows:

Monday, January 8, 2024 at 5:30 p.m. and Wednesday, January 10, 2024 at 10 a.m. in the Gulfport City Hall Council Chambers

Residents are urged to attend, particularly low, very low, extremely low income and public housing residents, minorities, and those with mobility, visual, and hearing impediments. Those individuals who wish to participate but may be hindered by disabilities or are non-English speaking are urged to call the Community Development Department at 228-868-5705 ext. 6638 at least three (3) weekdays prior to the hearing so reasonable arrangements can be made.
